### Size

The minimum stand size is 9m<sup>2</sup>. The stand depth is 3 meters, so the stand size must be a multiple of 3 (9, 12, 15 etc.). If you prefer a larger stand than 15 m<sup>2</sup> please contact us for more information.

### Stand equipment

The standard package of stand equipment includes carpets, two bar stools, one standing table, one brochure rack, three spot lights, power consumption, waste basket and a sign with the name of your institution.

## Regulations

1. This contract concerns all Educational Fairs organized by TMS Ltd. and Utdanningsmessene Ltd. included the exhibition area. The organizer retains the right to postpone or cancel any exhibition. The exhibitors may receive a stand- and registration fee refund, deducting exhibition expenses, but have no claim on compensation beyond that.
2. The application is binding, and the exhibitor is liable for the total amount of the registration- and stand fee if a cancellation is made. The application is binding even if the organizer moves the exhibition to a different location, but only within the same city.
3. The organizer retains the right to close registrations or to reduce the area applied for if the exhibitions should be fully subscribed prior to the deadline date. The organizer has the final decision with regard to the allocation of space.
4. Registration- and stand fee is to be paid a minimum of 2 months prior to the exhibition. If the terms of payment are disregarded, it may lead to loss of the allotted area.
5. Sub-leasing is not allowed. Only exhibitors that are registered and have pre-paid the registration- and stand fee may participate at the exhibition. Agents and those representing more than one organization/institution, have to make a separate agreement with the organizer in order to be allowed exhibiting.
6. Posters, etc. may not be put up in the exhibition area (only in the exhibitors own stand).
7. The exhibitor is responsible for any damage done to the buildings, furnishings, installations and persons. The exhibitor must follow the rules and instructions issued by the organizer and the Norwegian Authorities, and must accept the changes the organizer may find necessary.
8. The organizer will take care of security, but has no responsibility concerning exhibited commodities, equipment and property of any third person. Exhibitors must arrange for the necessary insurance on their own account.
9. The exhibitor must take care of transport, assembling, dismantling, packing and driving away of his equipment and decoration materials.
10. When the exhibition is over, the stand is to be returned free of decorations, foundations, etc. Should this be neglected, the organizer reserves the right to have this done at the expense of the exhibitor.
11. The organizer is not responsible for services and work done by the exhibitions subcontractors.
12. The stand is to be rigged and manned in the opening hours, through the whole exhibition. This, to ensure all visitors the same offer.
13. Registrants are committed to follow these regulations, regardless of any reservations made of any kind.
14. The organizer has the right to reject exhibitors' access to the fairs at application and during the fairs, if the organizer thinks the exhibitor does not fit in to the fair theme. The organizer will refund any paid registration and stand fee, all other costs are excluded.
